Members Present: Michele Keith, Mari Matt, Dr. Lisa Dana, Mary Wermers, Dr. Jason Colombino, Sean Emberley, Phyllis Boyd, Mark Strout, Richard Stoney, Mary Beth Verry and Angela Tsiumis.

Minutes: May minutes were provided by Angela, approved by Mark Strout, seconded and passed unanimously. There are no June minutes as we held our *Breakfast of Champions* in June to end the year.

Treasurer's Report: Michele provided a Treasurer's Report which was budgeted for a loss, and we had a gain. She expects to see a drop in interest rates over the next couple of years, which will then have us not seeing as much of a gain. In 2018 we looked good. In 2019, the Executive Board met and put a Budget together with more expenses than this year, hoping to come in higher with less expense. Insurance is paid and Michele will meet with Cornerstone Financial in November to go over finances and investments. As of August 31, 2019, the DEEP Operating Account had \$10,365.08; the Morse Investment had \$206,115.99; and the DEEP Investment had \$113,199.73, totaling \$329,680.80. Mark Strout approved the Treasurer's Report and the Budget for the 2019/2020 year. It was seconded and passed unanimously.

Wine Tasting: This year's winetasting will be held on Thursday, October 24, from 6 to 9pm. at the Danversport Waterfront. The theme is going to be Country/Western. Some of the restaurants participating in this year's event are: Burtons, Kelly's Roast Beef, Danversport, Texas Roadhouse, Daniella's and Tony C's. Tickets are \$40 and are available online, at Merchants Liquor Mart, or from Sean Emberley at DHS.

We are in need of more food vendors, raffle items, gift cards and volunteers for the evening of the event. If you can provide any help, please reach out to either Mari, Angela or Mary Beth.

Downtown Holiday Festival: We have this back on the agenda because DEEP was approached to see if we would consider doing it again this year. After much talk and consideration, DEEP decided to do it. It will take place on Saturday, December 7, from 3 to 5pm. Mark Strout approved DEEP to run the Holiday Festival for one more year and not to spend more than \$500.00 in expenses. It was seconded and passed unanimously.

Teacher Grants: In June, DEEP awarded more than \$18,000.00 in Teacher Grants. In November, DEEP will hold its monthly meeting at the Thorpe School in order to see the new Sensory Hallway that was made possible through a DEEP Teacher Grant.

This year, DEEP is going to pilot Fall and Spring Teacher Grant cycles to give teachers the opportunity to apply for grants before the spring, if they wish. More information will become available after the Wine Tasting to see what we bring in for money. DEEP is also exploring the possibility of piloting a Student Grant Program. This is still in the works and will not be available until 2020.
